Subject:- VISIT OF THE SECRETARY, INDUSTRIES AND COMMERCE DEPARTMENT, GOVERNMENT OF SINDH TO THE KDA OFFICERS CLUB AND MEETING HELD WITH ADMINISTRATOR, KDAOC AND THE HONOURABLE MEMBERS OF THE KDAOC IN THE OFFICE OF THE ADMINISTRATOR, KASHMIR ROAD KARACHI ON 13TH JULY 2025 AT 8.00 P.M.

On the invitation of the Administrator, KDAOC, the worthy Secretary, Industries & Commerce Department, Government of Sindh, Karachi has visited the KDA Officers Club of Kashmir Road, Karachi on 13/07/2025. The Administrator, KDAOC accompanied with the members of his Working Committee Mr. Irfan Raza and Mr. Ashoor Abbas as well as other working team including Mr. Agha Fareed, Club Engineer and Mr. Tahiruddin, Maintenance Supervisor, have also welcomed the worthy guest and handed over him a couple of flower vase.

2. During the meeting, the Administrator, KDAOC given a briefing in respect of the present situation as well as the progress of the ongoing tasks/endeavors which he is performing since his appointment as Administrator, KDAOC for betterment of the members & KDA Officers Club and making feasible atmosphere for holding fair, free and impartial election of the club. The Administrator has also categorically obtained confidence of the honorable Guest for the progressive senior being undertaken by him towards embarking interest of all the members of the KDA Officers club.

3. The Secretary, Industries and Commerce Department, Government of Sindh, Karachi shown his admiration, inspiration and satisfaction on the activities, achievements and progress. He announces his fullest support and sincerest wishes for the Administrator, KDAOC.

4. The following issues were also discussed and decisions were taken in the presence of the worthy Secretary, Industries & Commerce, Government of Sindh:-

- i) That the election of the KDAOC will be conducted at any cost after completion of legal formalities which have already been initiated. The Administrator, KDAOC informed the honorable members of the Club that there is no any ambiguity of whatsoever nature in holding free, fair and impartial elections, He firmly assured all the members that elections would be conducted after fulfillment of required legal formalities which was highly appreciated by all participants including

- worthy Secretary. The Administrator also advised the members not to indulge in any negative propaganda.
- ii) Senior Member of KDAOC Mr. Mohammad Ashraf proposed that 30% discount may be allowed to members of KDAOC on food in the Club Mess immediately. The Administrator, KDAOC kindly accepted the request immediately and announced 30% percent discount on food items to be provided in the mess of the Club on daily basis. He also announces that 30% percent discount on food has also been given on food in the B.M.Ball Room and the main lawn of the KDAOC which is going to be started as soon as possible and is near to be completed within a week's time.
- iii) Mr. Mohammad Ashraf has also pointed out that payment of outstanding dues of membership is also a very hardship specially for the retired officers of the KDA. He added that due to the present financial constraints, the delay in distribution of salaries and pensions are frequent because of which the members are not in a position to deposit the outstanding amount of membership in one go, He requested and suggested that the Administrator, KDAOC may kindly take a lenient view of the position explained and as a special case accord approval of some discount or waiver of the outstanding amount for the ease and comfort of the members. Mr.Rustam Ali Khan has also seconded his point of view and additionally suggested to hold AGM and approval from the 1/3rd majority be obtained in this respect.
- iv) While responding the above requests/ suggestions of two very senior and dignified members of KDOC, the Administrator stated that the vetting has since been received from the Law Department, Government of Sindh on our own request so that any concession or waiver of the outstanding dues of membership fees shall not be considered. However, he added that as per directives/decision of the Legal Department, GoS, the process of payment of outstanding

amounts has been started and many members have cleared their dues and are clearing gradually and the system will run till the last date of the notice which has already been circulated among the members of the KDAOC. After expiry of the given date, the process of serving individual notices will be started in which final date of payment will be allocated and after that process for termination of membership will be started as per the Law/Rules or Bye-laws.

- v) The Administrator, KDAOC in the presence of the worthy Secretary also announced that facilities like indoor cricket and Pedal Court has would be introduced and started in the KDAOC premises within a shortest period, so that income of Club could be enhanced and the members may enjoy the ___ facilities.
- vi) Senior member Mr. Rustam Ali Khan pointed out that still a long period is required to clear the court case otherwise we would be able to re-construct the building of our club. In reply the Administrator, informed the participants that the court matter has already been taken up and a Legal Committee has also been formed in this respect depicting KDAOC's point of view and an appeal of all cases would be filed within the shortest time.
- vii) The Administrator, KDAOC informed the participants that he visited the Farm House of the KDAOC situated at Gaddap Town, opposite Baqai University admeasuring 02 acres of land recently and found that the condition of the Farm House is very deteriorated. Previously some construction work was undertaken but due to some reasons or the other, the work could not be completed. He pointed out that 25% of the expenditure can be saved with proper planning and further process in the matter. He added that appropriate action in this respect would also be taken very soon.
- viii) Another Senior Member Mr. Yawer Mehdi seconded by Mr.Fuzail Bukhari requested the Administrator to take necessary severe action against Mr.Imran Aijaz on his mal-practices and non-gentleman

activities and running the Sports Complex under the name of KDA Officers Association on his sweet will without having any legal authority or custody. He is also a culprit of disbursement of funds of the members of the Association at his own accord. They requested to terminate his membership of the KDAOC and after conducting enquiry or probe in to the matter. Mr. S.Mukarram Sultan Bukhari has also pointed out that the Karachi Development Authority has also funded an amount of Rs.13,000,000/-(One Crore thirty lacs of Rupees) towards running of Sports Complex under the name of Association and also requested that the enquiry conducted for recovery of payment from the Ex-Administrator Mr. Muhammad Sarfaraz Khan.

ix) The raised objections were discussed with detail and the decision is kept as a "saved decision" and action in this respect shall also be taken as soon as possible after due enquiry.


6. Mr.Rustam Ali Khan, Mr.Mohammad Ashraf, Mr.S.Mukarram Sultan Bukhari, Mr.Fuzail Bukhar, Mr.Yawer Mehdi and Mr.Abul Razzaq Ghangro unanimously thanked the honorable guest for being with them. They also appreciated the wisdom, keen interest and the cooperation being extended by him for the betterment and wellness of KDAOC. They also expressed their whole hearted and warm welcomed sentiments before the worthy Secretary as a gesture of goodwill. They also requested the Honourable guest to please spare your valuable time for time to time visits to KDAOC.

7. The worthy Secretary, shown his utmost satisfaction on the overall performance of Administrator, KDAOC and appreciated in accordance with the Byelaws and also within the ambit of his jurisdiction. He ensured his guidelines, assistance and cooperation for every legal support in the interest of KDA Officers Club.

8. In the last, the Administrator, KDAOC also thanked and exchanged his good wishes. He expressed that the support and guidance of the worthy

Secretary, certainly boost his enthusiasm in discharging his responsibilities to meet the challenges assigned to him by his Superiors. The meeting was finally ended with votes of thanks and prayers for the better future for KDAOC as well as its honorable members. The Secretary (honorable guest) also visited the Swimming Pool and Gymnasium and instructed to make these facilities functional without any delay so that to the end-users may enjoy as early as possible.

9. After the lengthy and detailed meeting, a dinner was hosted by the Administrator, in the honor of the worthy Secretary and for all the participants.
