Subject: LEGAL OPINION FROM LEGAL DEPARTMENT

The undersigned was appointed as Administrator, KDA Officer's Club, Kashmir Road, Karachi, registered under Societies Registration Act 1860, vide Notification No.SOII(IND)14-108/2022, dated 21.05.2025. The Notification issued for a period of 90-days in the affairs of KDAOC to conduct free and fair elections of the Managing/Executive Committee of the Club and handover the charge to newly elected office bearers.

After assumption of charge as Administrator, over here in KDAOC, first of all I gone through the Memorandum of the Association KDAOC. The few articles pertain to the eligibility of members of KDAOC, are reproduce below for your perusal please.

3.6 KDA DUES.

One year membership fee may be paid in advance in the KDAOC office on the 1st of January of each year as per bye-laws stated, hereunder:

3.6.1. Arrears: If a member is in arrears of dues to the KDAOC for one year, his membership shall be terminated after 15 day's notice.

3.6.2. A member whose membership has been terminated solely for non-payment of dues may be re-instated on clearly payment and paying such fines as may be prescribed by the Managing Committee subjects to maximum of 10% of fee due.

Article 6: ELIGIBILITY OF VOTERS;

6.1. All valid members of KDAOC in good standing whose dues are cleared up to at least for the full calendar year in which the elections are held, shall be eligible to vote except those whose membership has been terminated.

THE KDA OFFICERS CLUB

1. NAME OF THE SOCIETY:

The name of the Society shall be the "THE KDA OFFICERS CLUB" (hereinafter referred to also as the KDA Officers Mess).

2. REGISTERED OFFICE:

The registered office of the KDAOC shall be situated in the building where currently the KDAOC is located, Off Kashmir Road, Karachi, owned and operated by the KDA Officers grouped as a club or officers Mess which property is the property of the KDAOC.

3. AIMS & OBJECTS OF THE KDAOC:

- 3.1 To settle disputes if any amongst the members amicably.
- 3.2 To create sprit of mutual help and sympathy amongst the members of the Association.
- 3.3 To make arrangements for the burial of dead bodies.
- 3.4 To establish dispensaries and provide health facilities to the members of Association as charitable basis.
- 3.5 To provide basic knowledge for safety purposes to the members of the Association.
- 3.6 To promote brotherhood and friendship amongst the members of the Association.
- 3.7 To promoter/office bearers and members shall not be paid employees of the Association.
- 3.8 The Association shall be run on non-political, non-commercial and non-religious basis.
- 3.9 The Association shall confine its activities only to the aims and objects of the Association and the income and property of the Association from whatever sources derived shall be applied solely towards the promotion of the objects of the Association and no portion thereof shall be paid by way of dividend, profit, bonus to any member office bearers of the Association or otherwise. Violation of this condition will be personal responsibility of the office bearers or members concerned.

2 Members Obligations

Every Member belonging to any class shall be bound to further, to the best of his ability, the objects, interests of the KDAOC and shall observe all rules and regulations of the KDAOC

3.3 Refund Of Subscription Paid In Advance

A person not admitted as a Member shall be entitled to have the amount paid by him in advance for purposes of admission refunded to the extent of 75% of the fees. The remaining 25% being retained by the KDAOC as service fee.

3.4 Termination/Suspension Of Membership

The membership of a member may be terminated / suspended on any one or more of the following grounds.

- 3.4.1 For non-observance of any of the regulations of the Club, by a resolution of a majority of the members present in person at a meeting of the Managing Committee.
- 3.4.2 On his resigning from the membership by a letter addressed to the Secretary of the Managing Committee.
- 3.4.3 On his being found to be of unsound mind by a court of competent jurisdiction.
- 3.4.4 On his being adjudged insolvent.
- 3.4.5 On his being finally convicted by a Competent Court, tribunal or authority of any offence involving moral turpitude.
- 3.4.6 On his acting contrary to the interests of the KDAOC.
- 3.4.7 In case of subscribing members, if the annual subscription remains in arrears for more than one year from the date it becomes due or from the date of issue of a reminder by the Secretary of the KDAOC.
- 3.4.8 On death of the member.

3.5 Restoration Of Membership:

Any member of any class whose membership is terminated in accordance with 4.4.1, will be given an opportunity of being heard by the Managing Committee who shall be competent to hear and decide the appeal. If such a member is also a member of the Managing Committee and he shall be barred from voting.

Any subscribing member whose Membership is terminated in accordance with 4.4.7 may apply to the Club for restoration of membership. The Managing Committee may restore the membership on payment of fees due.

3.6 KDAOC Dues.

One year membership fee may be paid in advance in the KDAOC Office on the 1st of January of each year as per bye-laws stated, hereunder.
